The undersigned, for the purposes of forming a corporation under the Plorida general Corporation Act, hereby adopt the following Articles of Incorporation.

> ARTICLE ONE NAME

EFFECTIVE DATE

The name of the corporation is Whiteraft Enterprises, Inc.

#### **ARTICLE TWO** DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.
