ARTICLES OF INCORPORATION

THE UNDERSIGNED, incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following articles of Incorporation.

ONE: The name of the Corporation is:

C. V. K., INC.

TWO: The principal place of business and mailing address of this Corporation shall be:


