## **Article I - Name**

The name of the corporation is: J. Ross Enterprises, Inc.

**Article X - By-Laws**

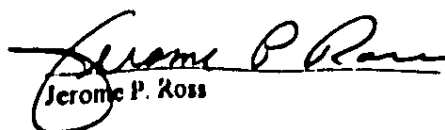
