THE UNDERSIGNED, being over the age of eighteen years, in order to form a corporation pursuant to the provisions of the Corporate Code, hereby certifies as follows:

**FIRST - IDENTIFICATION**

The name of the corporation, hereinafter referred to as the "Corporation," is Tubelight, Inc.

**SECOND - PERIOD OF EXISTENCE**

The period during which the corporation shall continue is perpetual.

**THIRD - REGISTERED OFFICE AND REGISTERED AGENT**

The address of the initial registered office of the Corporation is 8750 Huntfield Street, Tampa Florida 33635, and the name and address of the initial registered agent therein and in charge thereof, upon whom process against the Corporation may be served, is Joshua S. 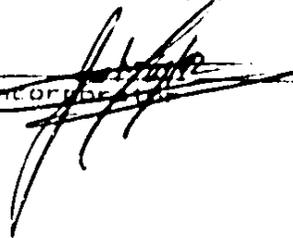

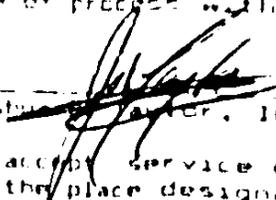

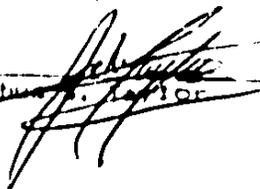
