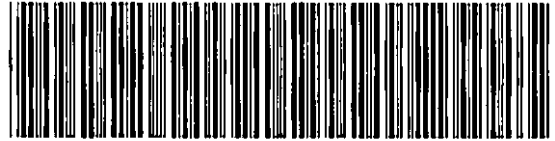

The name of the corporation being dissolved is F. Andrews Taintor, P.A., a Florida professional association (the "Corporation").


ARTICLE II. EFFECTIVE DATE OF DISSOLUTION
