**ARTICLE I. NAME**

THE NAME OF THIS CORPORATION IS KENT'S CARPET AND VINYL SERVICE, INC.

**ARTICLE II. COMMENCEMENT**

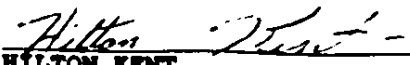

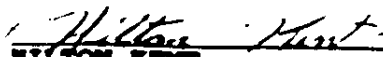
