ARTICLES OF INCORPORATION

OF

Clean Cut Lawn & Grounds, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE
June 1, 1996

The name of the corporation ("Corporation") is Clean Cut Lawn & Grounds, Inc.

ARTICLE II

The existence of the corporation shall begin on June 1, 1996, and shall be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is 930 Whippoorwill Drive, Palm Harbor, Florida, 34683.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
