ARTICLES OF INCORPORATION OF A+ POOLS, INC.

The undersigned incorporator, for the purpose of forming of corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation shall be A+ Pools, Inc.

ARTICLE II - DURATION

The duration of the Corporation shall be perpetual or until dissolved on a vote of the Shareholders as hereafter provided.

ARTICLE III - PURPOSE

The purposes for which the Corporation is organized are the following:


