The undersigned subscriber to the Articles of Incorporation, natural person competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE 1

The name of this corporation is:

J. D. THOMPSON MANAGEMENT, INC.

ARTICLE 2

The general nature of the business to be transacted by this corporation is: To manufacture, purchase, acquire, to own, mortgage, pledge, assign, transfer or otherwise dispose of, and to invest in, trade in and deal with, goods, wares, merchandise, real and personal property, and services of every kind, class and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, fraternal benefit society, mutual fire insurance association, cooperative association, state fair or exposition.

ARTICLE 3 CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 500 shares of common stock at no par value. Stockholders shall have a preemptive right to acquire, upon the sale for cash of unissued treasury stock of the corporation their pro-rate share thereof, of the same kind, class or series that they already hold, at the price offered to others, which price may be excess of par value.

ARTICLE 4 INITIAL CAPITAL

The amount of capital with which this corporation shall begin business, is \$500.00.

ARTICLE 5 TERMS OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE 6 ADDRESS OF CORPORATION
