THE UNDERSIGNED, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Plorida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

# ARTICLEJ

# Name and Address

The name of this Corporation shall be IMPLEMENTATIONS, INC. and its physical and mailing address shall be 1829 East Kaley Street, Orlando, Florida 32806.

# ARTICLEU

# Commencement of Corporate Existence
