ARTICLE I - NAME

The name of the corporation is PALLEY PROMOTES, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.


ARTICLE X - INDEMNIFICATION




