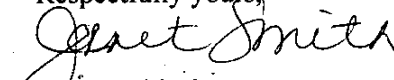
Dear Sir/Madam:

On Friday, December 1, 2000, I spoke with one of your representatives, Tyrone Scott, regarding the above taxpayer, All Around Docks, Inc. I explained to Mr. Scott that our client states that he never received the Uniform Business Report, even though he is the registered agent and the address is correct for the registered agent. While doing research for our client, we realized that All Around Docks, Inc. is in an "inactive" status with the State of Florida. We have been advised that during the month of January a substantial bulk mailing was submitted to all the corporations throughout the State of Florida and many of them had been misplaced or mis-mailed for whatever reason. In doing my research, I had found that the address was incorrect and the Uniform Business Report could have been returned due to the fact that the address was incorrect. It appears the address was never changed with the state even though it changed on the registered agent line submitted on an annual basis.
