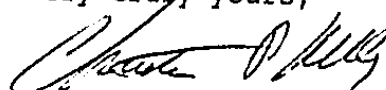

ARTICLE I
CORPORATE NAME

The name of this corporation shall be:
INVESTORS 2000, INC.

ARTICLE II
DURATION

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpotually thereafter unless sooner dissolved according to law.

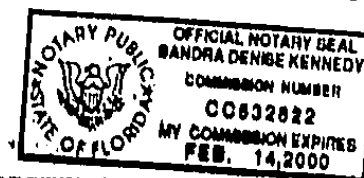

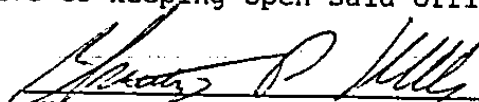
