ARTICLES OF INCORPORATION

OF

PRECISION PROPERTY INSPECTION SERVICES, INC.  
STATE OF FLORIDA

ARTICLE I. CORPORATE NAME.

The name of this corporation is: Precision Property Inspection Services, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock (having a par value of \$1.00 per share).

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence, commencing upon filing of these articles.
