The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

ARTICLE V PURPOSES OF THE CORPORATION

Purposes: To provide Medical Physics and Dosimetry services including clinical support, educational services, and engaging in research and development.

Also to engage in the analysis, design, development, and implementation of computer systems and services; including standalone, Intranet, and Internet systems and services.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE VI PERSONAL LIABILITY OF SHAREHOLDERS

The owners/shareholders are not personally liable for debts and obligations of the corporation. They can personally lose only to the extent of their investment in the corporation, with the exception that they can be personally liable for certain types of taxes, such as payroll taxes withheld from the employees' paychecks but not paid to the Internal Revenue Service and state tax authorities.
