The name of this corporation is R & B TILE &

new stock of this corporation of the same kind, class or



The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X - INDEMNIFICATION

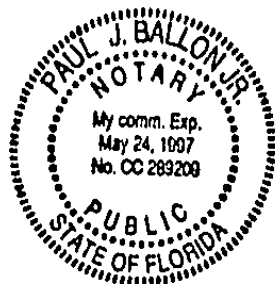


