**ARTICLES OF INCORPORATION
OF
S. EL. TRADE, INC.**

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is S. EL. TRADE, INC.. The principal place of business of the corporation is 4753 Estero Boulevard, #402B, Fort Myers Beach, Florida 33931. The mailing address of the corporation is 6371-4 Presidential Court, Fort Myers, Florida 33919.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

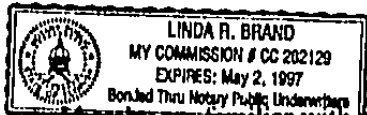
