Pursuant to Section 607.1403, Florida statute, the undersigned corporation has determined to dissolve as of September 15, 2001.


FIRST: The name of the corporation is R-A-H Services, Inc..



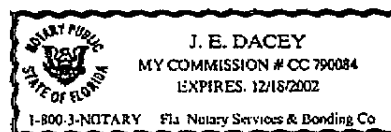
