## **ARTICLES OF INCORPORATION**

#### **OF**

## JVP ENTERPRISES, INC.



The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

## ARTICLE

The name of this Corporation is JVP ENTERPRISES, INC.

# **ARTICLE II**

This Corporation shall commence upon the execution of these Articles and perpetually.
