

**ARTICLES OF INCORPORATION

**ARTICLE I--NAME**

The name of this corporation is Tri-State Painting, Inc., 8288 Chickasaw Trail, Tallahassee, FL 32312.

**ARTICLE II--DURATION**

This corporation shall have perpetual existence.

**ARTICLE III--PURPOSE**

This corporation is organized for the purpose of transacting any lawful business for which corporations may be incorporated under chapter 607, Florida Statutes, as now exist or may after be amended.

**ARTICLE IV--CAPITAL STOCK**

This corporation is authorized to issue 100,000 shares of ~~No~~<sup>1/2</sup> Par Value common stock which shall be designated as "Common Shares".

**ARTICLE V--PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


### ARTICLE IX--INDEMNIFICATION

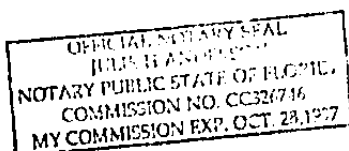
