**ARTICLE I**

**Corporate Name**

The name of this corporation is **MEDICAL TEMPORARY MANAGEMENT, INC.**, and its principal office and mailing address is as follows: 3150 South Fletcher Avenue, Suite 401, Fernandina Beach, Florida 32034.

**ARTICLE II**

**NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to provide temporary nursing and other staff requirements to hospitals and other facilities and to engage in any other business activities which are lawful pursuant to the laws of the State of Florida and the United States of America.

**ARTICLE III**

**Capital Stock**




