The name of the corporation is SUSTAINABLE CAMPS & RESORTS, INC, and its mailing address is 500 East Broward Boulevard, Suite 1950, Fort Lauderdale, Florida 33394.

#### ARTICLE II

The corporation shall have perpetual existence.

#### ARTICLE III
