# ARTICLES OF INCORPORATION

OF SPECTRUM DX SERVICES, INC.

#### **ARTICLE 1 - NAME**

The name of this corporation is SPECTRUM DX SERVICES, INC. located at 4310 Sweet Bay Avenue, Melbourne, Florida.

# **ARTICLE IL-DURATION**
