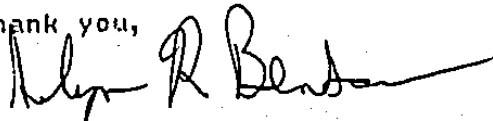
I immediately revised my application with the name A.R. Benson, Inc. and resubmitted it along with a copy of the letter from Terri Buckley as instructed.
