**ARTICLES OF INCORPORATION
OF

Article I - Name

The name of the corporation is: **HEWITT INDUSTRIES, INC.**


Article IX - Initial Officers



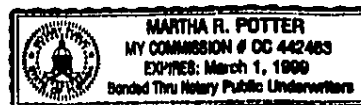
