**ARTICLES OF INCORPORATION
DYNAMIC MANAGEMENT CORP.**

ARTICLE I-NAME

The name of this Corporation shall be DYNAMIC MANAGEMENT CORP.

ARTICLE II-DURATION

The Corporation shall have perpetual existence commencing upon the date of filing of these Articles with the Department of State.



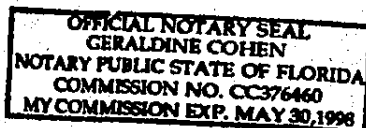
