ARTICLES OF INCORPORATION

OF

ARTICLE I

CORPORATE NAME

The name of the corporation shall be SHERI NORMAN, INC.

ARTICLE II

DURATION

The corporation shall have perpetual existence, unless sooner dissolved according to law.
