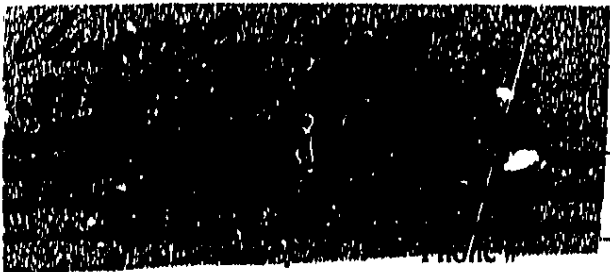

ARTICLE I - Name

The name of this Corporation is **Lee & Anne Clagett, Inc.** The principal place of business of this Corporation shall be 4015 Honney Bee Point, Sanford, Florida 32773.

ARTICLE II - Duration

This Corporation shall begin existence on June 14, 1996, and exist perpetually.

ARTICLE III - Purpose

This Corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of one dollar (\$1.00) per share, and shall be fully paid in cash, property, labor, or services at a just valuation to be fixed by the Board of Directors.

ARTICLE VI - Limitation of Liability

Each Director, Stockholder, and Officer, in consideration for his or her service, shall, in the absence of fraud, be indemnified, whether then in office or not, for any and all reasonable costs or expenses incurred by him or her in connection with the defense of, or for advice concerning any claim being asserted or proceeding brought against him or her by reason of his being or having been a Director, Stockholder, or Officer of the Corporation to the maximum extent of the law. The foregoing right of indemnification shall be inclusive of any other rights to which any Director, Stockholder, or Officer may be entitled as a matter of law.

ARTICLE VII - Initial Board of Directors
