

ARTICLE 1 - NAME

The name of the corporation is: S.W.N.T. INTERNATIONAL, INC.

ARTICLE II - PURPOSES

This corporation is organized for the following purposes:

- A. To manufacture, produce, purchase or otherwise acquire, sell or otherwise dispose of, import, export, distribute, deal in and with, whether as principal or agent, goods, wares, merchandise and materials of every kind and description, and more particularly, but without in any way limiting the generality of the foregoing purposes, to buy, sell, manufacture, process, distribute and generally deal in and with, whether at wholesale or retail, yogurt, and dairy products, and creamery products of every kind and description; beverages; to manufacture, buy, sell and generally deal in and with all kinds of equipment, mechanical or mercantile specialties, devices, tools, implements, instruments and apparatus and machines used or useful in connection therewith, and to carry on any business or businesses incident to any of the foregoing with all the powers conferred upon corporations by the laws of the state of Florida now or hereafter in effect.
- B. To export from and import into the United States of America and its territories and possessions, and any and all foreign countries, as principal or agent, merchandise of every kind and nature, and to purchase, sell, and deal in and with, at wholesale and retail, merchandise of every kind and nature for exportation from, and importation into, the United States, and to and from all countries foreign thereto, and for exportation from, and importation into, any foreign country, to and from any other country foreign thereto and to purchase and sell domestic and foreign merchandise in domestic markets, and to do a general foreign and domestic exporting and importing business.
- C. To such extent as a corporation organized under the Business Corporation Law of this state may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other corporations, firms or individuals, all and everything necessary, suitable,

convenient or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this Corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the Business Corporation Law of this state or under any act amendatory thereof, supplemental thereto, substituted therefor.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue Fifty (50) shares of common stock without nominal or par value.


