The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be ACRO TECHNOLOGIES CORPORATION. The address of the principal office of this corporation shall be 2223 River Park Cir. #326, Orlando, FL 32817, and the mailing address of the corporation shall be the same.
