**ARTICLES OF INCORPORATION**  
**OF**  
**MANDARIN INTERIORS, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation is MANDARIN INTERIORS, INC.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation will provide Wholesale Sales of Furniture and Related Products and Services to Businesses and the Public.

**ARTICLE III - CAPITAL STOCK**
