ARTICLES OF INCORPORATION

OF

MAGNOLIA TRUCKING COMPANY, INC.

The undersigned subscribers to the Articles of Incorporation of MAGNOLIA TRUCKING COMPANY, INC., natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the corporation is MAGNOLIA TRUCKING COMPANY, INC.

ARTICLE II.

NATURE OF BUSINESS

The general character or nature of the business to be to be transacted by this corporation is:

- (a) To operate commercial trucking company, and to engage in the general business associated with trucking companies, including, but not limited to, transporting and hauling various commodities, products or materials.
- (b) To acquire by purchase, lease or other wise, lands and interests in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held or occupied by the corporation, buildings or other structures, now or hereafter erected on any lands so owned, held or occupied, and to encumber or dispose of any lands, or interests in lands, and any buildings or other structures, at any time owned or held by the corporation. - (d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.
