ARTICLES OF INCORPORATION

NATIONSHED MEDICAL GROUP OF DEERFIELD BEACH, INC.

A FLORIDA CORPORATION

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be NATIONSMED MEDICAL GROUP OF DEERFIELD BEACH, INC., and the initial address of this corporation shall be 7950 N.W. 53rd Street, Suite 210, Miami, Florida 33166.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III

The capital stock authorized, the part value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE_V

The initial office of this corporation shall be at 100 N.E. 3rd Avenue, Suite 400, Ft. Lauderdale, Florida 33301, with the privilege of having its offices and branch offices at other places within the State of Florida. The initial registered agent at that address shall be JAMES L. BERGER.

ARTICLE VI

This corporation shall have at least one director, with the exact number to be specified by he stockholders from time to time unless the stockholders shall, by majority vote thereafter, determine that the corporation be managed by the stockholders.

ARTICLE IX

No contract or other transaction between this corporation and on or more of its directors or any other corporation, firm, association, or entity in which one or more of hits directors are directors or officers or are financially interested shall be either void or voidable because of such relationship or interest, because such director or directors are present at the meeting of the board of directories or a committee thereof which authorized, approves, or ratifies such contract or transaction, or because his or their votes are counted for such purpose, if:

- (a) The fact of such relationship or interest is disclosed or known to the board of directors or committee which authorized approves or ratifies the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of such interest directors;
- (b) The fact of such relationship or interest is disclosed or known to the shareholders entitled to vote and they authorize, approve, or ratify such contract or transaction by a vote or consent sufficient of the purpose without counting the votes or consents of such interested directors; or
- (c) The Contract or transaction is fair and reasonable as to the corporation at the time it is authorized by the board, a committee, or the shareholders.

Common or interested directors may be counted in determining the presence of a quorum at a meeting of the board of directors or a committee thereof which authorizes, approves, or ratifies such contract or transaction.

ARTICLE X

The private property of the stockholders shall not be subject to payment of the corporate debts in any event.

ARTICLE XI

This corporation shall indemnify and may insure its officers and directors to the fullest extent permitted by law either now or hereafter.
