Pursuant to Section 607.1007 of the Florida Business Corporation Act, the undersigned, acting as incorporator of Sizzling Food Concepts, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is Sizzling Food Concepts, Inc.

ARTICLE II
