The undersigned, for the purpose of forming a corporation under the Florida General corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is PARADISE LAKES RESORT INCORPORATED.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized are:

1. To engage in any business or activity permitted under the laws of the United States and of this state.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is Eight Hundred Eighty Eight Trillion, Eight Hundred Eighty Eight Billion, Eight Hundred Eighty Eight Million, Eight Hundred Eighty Eight Thousand, Eight Hundred Eighty Eight (888,888,888,888,888). Such shares shall be of a single class, and shall have a par value of (\$.000000000001) per share.

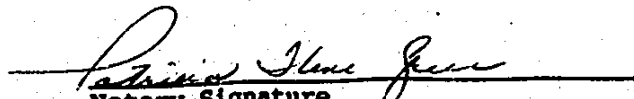

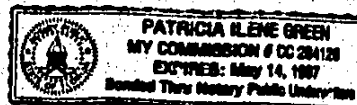
