The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation of forming a corporation under the laws of State of Florida:

ARTICLE I

NAME

The name of the corporation is **Crossroads of Life, Inc.**

ARTICLE II

COMMENCEMENT AND DURATION OF CORPORATE EXISTENCE

The corporation shall commence its corporate existence in the date of filing and acknowledgment of the Articles of Incorporation, and shall have perpetual existence.

ARTICLE III

GENERAL PURPOSE

The purpose for which this cooperation has been formed is: To engage in and transact any and all lawful business permitted under the laws of the State of Florida and of the United States.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to issue is one hundred (100) shares of common stock having a par value of one dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

Shareholders shall have preemptive rights.



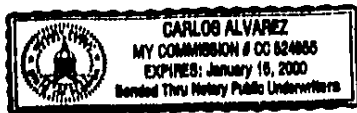
