The name of this corporation is Homa Survey Company.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.

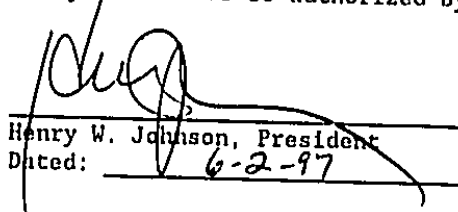

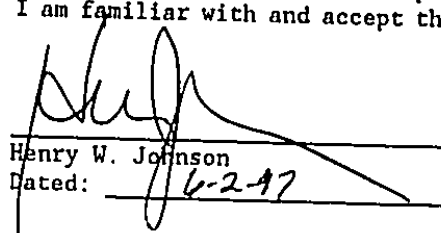
