ARTICLES OF INCORPORATION

OF

ALPHA OMEGA CONSTRUCTION GROUP, INC.



THE UNDERSIGNED subscriber to these ARTICLES OF INCORPORATION, being a natural person competent to contract, does hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

THE NAME of the corporation shall be ALPHA OMEGA CONSTRUCTION GROUP, INC.

ARTICLE II PURPOSE

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock, each share having a par value of One Dollars (\$1.00).

ARTICLE IV REGISTERED OFFICE

ARTICLE VI TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE VII LIMITATION OF LIABILITY

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he/she is also a director of such subsidiary or corporation.


