ARTICLES OF INCORPORATION

OF.

ARTICLE 1-NAME

The name of this corporation is R & B NAILS, INC. and the address of the corporation is 360 N.E. 8Th. Street, Homestead, Florida 33030

ARTICLE II-DURATION
