The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract for a corporation under the laws of the State of Florida, and does certify that they have become a corporation pursuant to the following Articles of Incorporation.

**ARTICLE ONE**

The name of this corporation is @ccess Net, Inc.

**ARTICLE TWO**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE THREE**

The corporation shall have all the powers given to it by the laws of the State of Florida, now or hereafter, and specific powers herein enumerated shall not be construed as a limitation upon the powers of the corporation.

**ARTICLE FOUR**

This corporation shall exist perpetually.

**ARTICLE FIVE**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock with a nominal par value of ten cents (.10)

**ARTICLE SEVEN**
