ARTICLES OF INCORPORATION

OF

ALL GENERAL REPAIRS, INC.

ARTICLE I: NAME

The name of this corporation is ALL GENERAL REPAIRS, INC. and the address of this corporation is 2984 Southwest 16th Street, Fort Lauderdale, Florida 33312.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE
