ARTICLES OF INCORPORATION
OF

The undersigned natural person, who is licensed or otherwise legally authorized to practice law in the State of Florida, hereby acts with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such corporation:

ARTICLE I - NAME

The name of this Corporation is JOSEPH R. GOMEZ, P.A.

ARTICLE II - DURATION

The period of the corporation's duration shall be perpetual.

ARTICLE III - EFFECTIVE DATE OF INCORPORATION

The effective date of these Articles of Incorporation shall be as of the date of filing with the Secretary of State.

ARTICLE IV - PURPOSE

The purpose of this Corporation is to engage in the practice of law as a professional legal corporation and to carry on services incident thereto.

ARTICLE V - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 100 shares of common

stock having a par value of \$1.00 per share. The capital stock may be paid for in money, property, labor or services, at a just valuation to be fixed by the incorporator or by the directors, at a meeting called for such purposes.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The initial principal office of this Corporation shall be 1269 S.W. 21st Street, City of Miami, County of Dade, State of Florida, 33145. The name of the initial agent of the corporation, located at such office, is Joseph R. Gomez, Esquire, which upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of one (1) member. The number of directors may be increased or decreased from time to time by vote of the Shareholders, but in no case shall the number of directors be less than 1. The names and addresses of the director constituting the initial Board of Directors is:

ARTICLE VIII - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and

approved at a Shareholders' meeting by 100% of the stock entitled to vote, unless all of the directors and all of the Shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


