The undersigned, acting as Incorporator of a Corporation pursuant to Chapter 807, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

Article I

The name of the corporation is: J.B.M. Paintball, Inc., and the initial principal address of the corporation is: 6210 N.W. 124th Place, Gainesville, FL 32606.

Article II

The corporation shall have a perpetual existence. Corporate existence shall commence upon filing with the Secretary of State.

Article III

The purpose or purposes for which the corporation is organized are: To promote and conduct "Paintball" contests and exhibitions of every kind and description and to license others to conduct and present the same on the premises of this corporation.. The corporation may also sell or lease any products, equipment or services in furtherance of said purpose and may hold tangible and intangible property in furtherance of said purpose.

Article IV

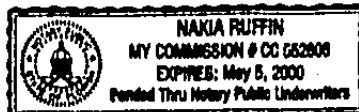
