ARTICLES OF INCORPORATION OF AMERICAN L.O.T.T.O. CLUB, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereb forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be American L.O.T.T.O. Club, Inc.

ARTICLE II. PURPOSE

The corporation shall provide services related to legally authorized gaming activities, including serving as a consultant for fund raisers by charitable and other organizations, publishing or promoting publications related to or associated with gaming and gambling, and perform any or all other lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 5,000 shares of common stock having no par value.

ARTICLE IV. ADDRESS

Both the principal address and the street address of the registered office of the corporation shall be 1111 N. West Shore Blvd., #115, Tampa, Florida 33607. The name of the initial registered agent of the corporation at that address is W. Stephen McConnell-who, by signing-at-the-end-of-these-Articles, hereby consents to be such registered agent.
