The name of this corporation is Taylor Graphics, Inc.

## ARTICLE II

This corporation shall exist perpetually, commencing on the date of the filing of these Articles.

# ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business.

# ARTICLE IV

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock.

#### ARTICLE V

# ARTICLE VI

### ARTICLE VIII

The initial street address of the Corporation's registered office is 1504 S.W. 1st Street, #1, Fort Lauderdale, Florida 33312. The initial registered agent for the Corporation at that address is Paul Taylor.

### ARTICLE VIII

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, those shares of the common stock of this corporation which may be issued from time to time for money, property or past services in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

# ARTICLE IX

Each director of the corporation shall be elected by a plurality of votes of 70% of the authorized and issued shares of common stock of the corporation.

#### ARTICLE X

A director may be removed by a vote of 70% of the authorized and issued shares of common stock and only for cause.

### ARTICLE XI

These articles may be amended only with the approval by the holders of 70% of the authorized and issued shares of common stock of the corporation.
