The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby make and adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of this Corporation is G.E.C.S., INC., ("Corporation").

**ARTICLE TWO
PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation is 160 Softwind Trail, Maitland, Florida 32751.

**ARTICLE THREE
DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE FOUR
PURPOSES**

The Corporation is organized to engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way. Further, the Corporation may do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**ARTICLE FIVE

The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation.

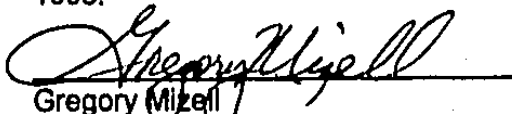
**ARTICLE TWELVE

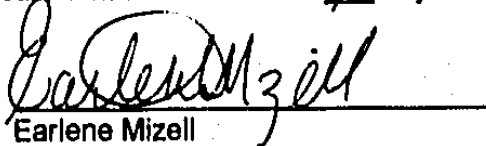
**ARTICLE THIRTEEN

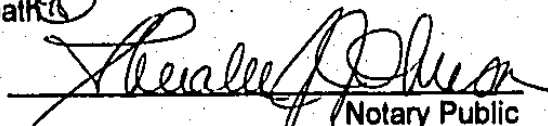

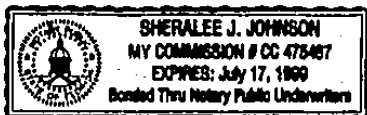

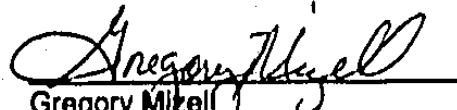
