ARTICLE I. NAME

The name of this corporation is CORI LYNNE EQUIPMENT CO., INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.

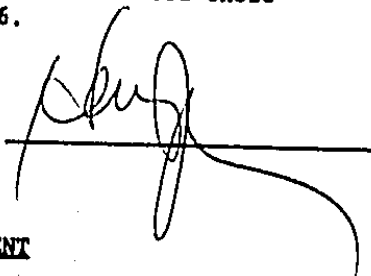
ARTICLE IX. INDEMNIFICATION

ARTICLE X. AMENDMENT

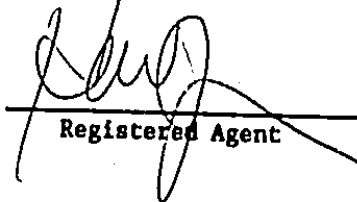
