The name of this corporation is BEST-EX, INC. The mailing address of the corporation is 433 Plaza Real, Suite 365, Boca Raton, Florida, 33432.

#### ARTICLE II: DURATION

This corporation shall have perpetual existence.

#### ARTICLE III: PURPOSE
