The undersigned subscriber to these Articles of Incorporation are natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I  
NAME**

The name of this Corporation shall be **SPEECH LANGUAGE PATHOLOGY ASSOCIATES, P.A.** The Corporation's principal address and the registered office address are the same.

**ARTICLE II  
DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III  
PURPOSE**
