ARTICLE XI-AMENDMENT

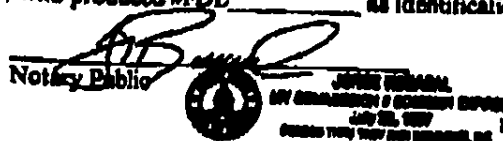
